Local Deputy Receives Special Recognition

Wednesday, December 13,2017 Deputy Christopher Smith of Galveston County PCT3 was working the Crystal Beach area. Deputy Smith attempted to stop the truck, which failed to pull over even with his lights and siren activated. Deputy Smith contacted he Galveston County dispatcher to let them know he had a motor vehicle that was failing to stop and the direction of travel. While the truck was not stopping they were only traveling at speeds of 70 mph. Deputy Smith attempted to pull alongside of the vehicle to try and get the attention of the driver. Deputy Smith immediately noticed that the driver was an elderly female and the passenger was an elderly male clutching his chest. Deputy Smith advised dispatch what he had just witnessed and had dispatch contact Port Bolivar EMS and have them stage at he Ferry Landing. Deputy Smith gave the elderly couple an emergency escort t the ferry landing. Upon arrival the ferry lading Deputy Smith made contact with the driver, who advised her husband was having a heart attack and that he had already taken two nitro pills. Port Bolivar EMS arrived



about 30 seconds later and rushed the elderly male to UTMB.

EMS Personnel informed this office due to the quick actions of Deputy Christopher Smith this Christmas was saved for the family. The elderly male had a history of heart problems including five stints and extremely high blood pressure. Deputy Sith was a life saver on this December 13, 2017. Galveston County awarded Deputy Constable of the Year to our own local law enforcement agent, Deputy Constable Chris Smith.

Beach Raking Clarification

There have been many questions, assumptions and misinformation about Galveston County’s current halt to raking Bolivar Peninsula Beaches. I will do my best to explain things. 1. When Galveston County rakes the beaches with the old style rakes that look like combs behind the tractor, our purpose is



not to grade, pack, move sand or pick up trash. The sole purpose is

to move seaweed and other naturally occurring materials. 2. When we used the new surf rake that is on wheels, we did pick up trash and debris because it has a hopper on it that collects the material and we were able to dump it in a receptacle.

3. We have always hand picked a majority of the litter whether it was our beach crew, a contractor or the many wonderful individuals that just want to do their part and with the help of Keep Bolivar Beautiful.

4. The US Army Corps of Engineers has jurisdiction of the beach under 2 different acts. One gives them jurisdiction basically from the wet sand seaward, the other is jurisdiction from the mean high tide line seaward which is an elevation that can be determined a few different ways. One way can put that line at the vegetation line of the dunes which encompasses our whole beach.

5. I know many of you are upset and want to call any and everyone that has authority, but we ask that everyone just hold tight while this is being figured out between Galveston County and the Corps of Engineers. If the time comes where the county is not making progress we will let you know. Angry calls from people not completely understanding could possibly slow down this process.

I just want to wrap this up by encouraging you all to consider what our beach looks like less than 1 week after what could potentially be our busiest weekend of the year. Although not perfect, it looks great considering what it looked like Monday morning. I assure you, we are going to do everything we can to keep our beaches visitor and resident ready. Thank you all that take you own time, golf carts, garbage cans, gloves etc and clean after the crowds leave.

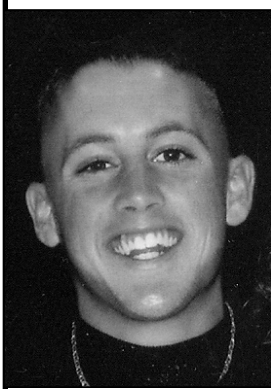

The tire tracks and movement on the beach make it impossible to locate a nesting turtle tracks.

Anyone working on the TX coast must have state and federal permits to work in the agencies jurisdiction.

The GLO manages the dunes, USFWS the land from the dune to the mean high tide line and the USACE the mean high tide line to the active water line.

Hand picking of trash is all that is permitted by the City of Galveston, so this is normal practice.

FBI Warns of Posting Hoax Threats to Institutions and Launches Campaign to Educate the Public to #ThinkBeforeYouPost

The Federal Bureau of Investigation is announcing a campaign to educate the public on the consequences of posting hoax threats to schools and other public places and reminds communities that these hoax threats are not a joke.

In the aftermath of tragic shootings such as the ones at Santa Fe High School in Texas and Marjory Stoneman Douglas High School in Florida, the FBI and law enforcement around the country often see an increase in threats made to schools and other public forums.

The FBI and our partners follow up on every tip we receive from the public and analyze and investigate all threats to determine their credibility. Federal, state, and local law enforcement then employ a full range of tools to mitigate those threats that are deemed credible. Making false threats drains law enforcement resources and cost taxpayers a lot of money. When an investigation concludes there was a false or hoax threat made to a school or another public place, a federal charge could be considered, which carries a maximum sentence of five years in prison. If a federal charge is not warranted, state charges can be considered.

Public assistance is crucial to our efforts to curb these hoax threats. We ask that the public continue to contact law enforcement to report any potential threats or suspicious activity. If there is any reason to believe the safety of others is at risk, we ask that the public immediately reach out to their local police department by calling 911, or contact the FBI via tips.fbi.gov or over the phone (1-800-CALL-FBI). As always, members of the public can call their nearest FBI field office to report a tip.

Early intervention can prevent a situation from escalating by identifying, assessing, and managing the threat. Remember, if you see something, say something. Hoax threats are not a joke, so think before you post.

Thank you for staying with us, and have a good trip home."

A good trip was just what I wanted!

I went to the last meeting, this time in the hotel restaurant. Keeping my bags close, I rolled them behind me. The bellman, Ted, who had met me at check-in offered to keep them for me, but wanting a quick departure, I declined. He looked unhappy, and I guess he had wished for an extra tip.

After about 20 minutes into the meeting, I started to fidget. My habit had always been to touch my necklace, a very nice gold hoop with a small gold coin attached. I always wore it. My parents gave it to me years ago, and it sentimental as well as valuable. As I reached for the necklace, I felt my empty neck - no necklace!

I panicked. Where was it? Then it dawned on me that I must have left it on the bedside table in my hotel room.

I quickly excused myself and hurried up to the a new desk clerk, a woman in her 30s with short blonde hair held back by barrettes. Her nametag read "Sherry. "I've left a necklace in my room," I frantically told her. "What room was it?" she asked. "617. Might I

go up to get it? I know where it is." She looked at her monitor. "No, somebody has already checked into that room, " she bristled. "I'll send a maid up stairs to look for it."

"Couldn't I go with her? I know where I left it."

"No -please sit over there, and I'll let you know if she finds anything," she answered pointing to a sofa as another customer stepped to the desk.

I quietly walked toward the sofa. Then I thought, "I'm going upstairs to see if I can find my necklace." I searched my purse. There at the bottom in the corner was the key card. Glancing toward her, I saw she was busy with that other guest. I headed to the elevators. "I'm going to get to that room, and she can't stop me," I fumed.

Room 617 was at the end of the hall on the sixth floor; I hesitated to go inside. I knocked loudly two times. There was no answer. I slid the card into the lock and, miraculously, my card worked; the door opened. The room was dark -just as I had left it this morning with an unmade bed. No one had checked into 617! I quickly went to the bedside table. The necklace wasn't there! I looked down next to the table. There, half hidden under the bed, was my gold necklace. It must've fallen off the table during the night. I scooped it up, and, with a great sigh, slipped it around my neck and fastened the clasp.

As I turned to go, I noticed something out of the corner of my eye. Looking more closely, I saw a shoed foot on the floor next to the other side of the bed. Hesitantly, I walked to that side. There lay the body of a man. He was wearing tan khakis and a brown hotel uniform shirt. I looked closer. He wasn't breathing. With horror combined, I will confess, with

curiosity, I realized that the man in my room was dead.

Just then there was a knock at the door, and the maid who had been sent to look for my necklace let herself in. She was as surprised to see me as I was to see her. Then she, too, saw the man's foot. Shaken up, but glad to be allowed to leave, I traveled back to Houston where I hoped to put this awful experience behind me.

It seemed that it was in the past until I got a call from Detective Monroe a few days later asking me to bring the necklace in for examination. The police wanted to see what fingerprints and possible DNA could be found. They seemed to have a lead, but I had no idea what they were looking for. Who besides Stephen had been in that room and had killed him ? I planed to take the necklace back to Fort Worth the next day. When I went to bed that night, I had no idea that I would not make it to Fort Worth. My nightmare had just begun.

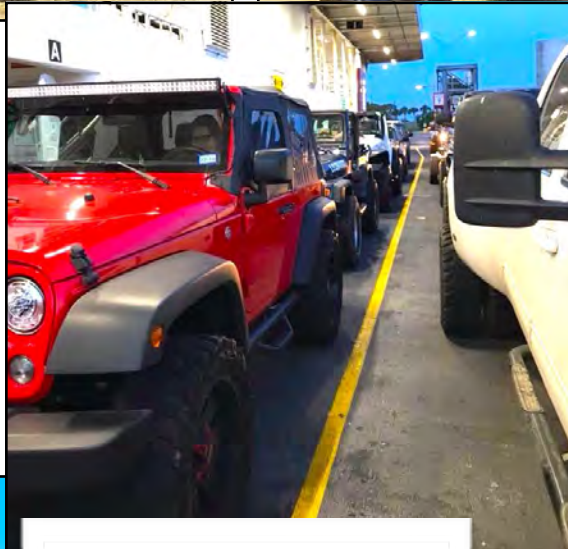

Item 1 Call to Order: At 6:00 PM President, Hollis Gassen, declared a quorum present and called the meeting to order.

Item 2 Pledge of Allegiance and moment of silence: The Pledge of Allegiance was led by Mr. George Strong and cited by all present. Afterwards, a moment of silence was observed.

Item 3 Approve minutes of the March 13, 2018 General Meeting:

A motion was made by Dennis Stafford and seconded by George Strong to approve the March 13, 2018 minutes as presented. Motion unanimously passed.

Item 4 Committee Reports:

Audit & Finance: Mr. Dennis Stafford reported the Audit and Finance Committee had met earlier today and reviewed the District's invoices, check registers and bank statements for March and found everything to be in order.

Item 5 Public Comments: There were no public comments.

Item 6 Manager's Report: The manager's report was presented by Mr. Jody Ball and the following items were reported and/or discussed:

1) A Review of Trial Balance, Comparative Budget Report and Account Balance Summary List: The Board reviewed the Trail Balance Report, Comparative Budget Report and the Account Balance Summary through March and found everything to

be in order.

2) Review System Operational Reports:

* District Water Losses. The District experienced a four-month average water loss through March of 14% and 14.29% for the month.

* The District has 4,891 active accounts through March. In March, 1 account was liquidated and 47 were shut-off for non-payment.

* Total water sales for March were \$278,611.75

* Average monthly water bill for March is \$56.96 and 2018 average is \$58.17.

* Water pumped was 25.5M gallons and water sold was 12.2M gallons with a loss difference of 13.3M gallons. There were 8 leaks repaired.

* No reportable accidents or incidents during the month of March.

3) Review current infrastructure projects: The Water Tower project drawings were received by BPSUD and were returned with minor modifications on site lighting and electrical connections. Tank logo was submitted. Construction is tentatively scheduled to begin in July pending the bidding process.

4) Rollover Pass: There is no additional information available.

5) Personnel: The District is fully staffed.

6) Finances: Net income for March is \$38,939.

Negotiations with LNVA on the cost for sludge removal from their settling ponds are continuing. The District is waiting on a written proposal from LNVA.

Item 7 Recognition of Barbara Cowie Office Manager of the year awarded by Texas Rural Water Association:

Ms. Barbara Cowie received the Office Manager of the Year award on Thursday at the TRWA conference and

was recognized this evening by BPSUD Board for her accomplishments.

Mr. James Edwards of J.R. Edwards & Associates presented a summary of the 2017 audit results. No problems were detected. The Board discussed the audit. A motion was made by Wayne Turk and seconded by Dennis Stafford to approve the 2017 Audit as presented. Motion passed unanimously.

Cooking with Miss “Obler”

A big THANK YOU to A.J., Jan Kent, and all the volunteers involved with the food bank in High Island each week. You are all much appreciated! We recently received a box full of wonderful, fresh vegetables(carrots, squash, potatoes, cabbage, zucchini) plus fruits (blackberries and mangoes). I couldn't wait to get home and start cooking.

Here is a good recipe for using leftovers:

LEFTOVER HAM AND CHEDDAR SCALLOPED POTATOES

1/4 cup (4 tablespoons) butter
2 cups whole milk or cream
2 teaspoons minced garlic
1 teaspoon salt
2 pounds Yukon gold potatoes, peeled and thinly sliced
1 cup (4 ounces) grated cheddar cheese
1 1/2 cups (about 8 ounces) cooked, diced ham
Garnish: fresh chopped chives, green onions, or parsley

Preheat oven to 400 degrees. Spray an 11 x 7-inch baking dish with cooking spray and set aside.
In a large pot, melt butter over medium-high heat. Whisk in milk, garlic, and salt. Add sliced potatoes.
Bring to a boil, reduce heat to medium-low, and cook (uncovered) for about 15 minutes (or until potatoes are tender).
Gently stir the potatoes periodically as they cook.
Add the ham to the potato mixture.
Spoon into prepared baking dish. Sprinkle with grated cheese.
Bake for 20-25 minutes, or until golden brown. Let stand for 5-10 minutes before serving.

BAKED ZUCCHINI CHIPS WITH PAPRIKA AND SEA SALT

1 zucchini
1 tablespoon olive oil
Sea salt, pepper, and paprika to taste

Cut a zucchini into thin slices and toss in 1 tablespoon olive oil, sea salt, and pepper. Sprinkle with paprika and bake at 450 degrees for 25 to 30 minutes.

PARMESAN ROASTED CARROTS

Cooking spray
1 pound carrots, peeled and cut into sticks
1 teaspoon extra virgin olive oil
1/2 teaspoon salt
1/4 teaspoon pepper
1 tablespoon fresh thyme
3 tablespoons Parmesan cheese, grated

Preheat oven to 450 degrees. Grease a medium sized casserole dish with cooking spray.
Add carrots, olive oil, salt, pepper, and thyme in a bowl and toss to combine. Place in casserole dish.
Roast, uncovered, for 8 minutes and then stir. Put back in the oven for an additional 8 to 12 minutes, or until carrots are roasted to your desired tenderness. Remove from oven and sprinkle on Parmesan cheese. Toss to combine. Serve hot.

THE BEST BLACKBERRY CRISP

TOPPING:
1 1/2 cups old-fashioned or quick oats
1 cup all-purpose flour
1 cup brown sugar
1/4 teaspoon salt
1 cup (2 sticks) butter, cut into tablespoon-size pieces

FRUIT:
8-10 cups fresh blackberries (about 24-36 ounces), washed and dried well
1/3 cup granulated sugar
1/3 cup all-purpose flour
1 tablespoon fresh lemon juice

DIRECTIONS:
Preheat the oven to 350 degrees.
In a medium bowl, whisk together the oats, flour, brown sugar, and salt.
Add the butter and cut it into the dry ingredients with a pastry blender or a couple of forks until the mixture is crumbly and the butter is evenly cut in. Set aside.
In another bowl, add the blackberries, sugar, flour, and lemon juice. Stir until combined.
Lightly grease a 9 x 13-inch pan and spread the fruit mixture on the bottom.
Sprinkle the crisp topping evenly over the top.
Bake for 45 minutes until the fruit is bubbly and the crisp topping is golden (add time, if needed).
Remove from the oven and let the fruit crisp rest for 10-15 minutes before serving (the fruit layer will thicken as it cools). Serve warm or at room temperature with ice cream (or lemon frozen yogurt) or sweetened, whipped cream, if desired.

Recently your 'umble scrivener noted on a news site from far away a report about a young man who had spent some time in prison but had now redeemed himself with the gift of music. While he was in prison he rented a guitar for a nominal sum and had taught himself to play it.

The redeemed was pleased to talk about himself, his tattoo celebrating his release from prison, his progress in

making himself a better person now, his feelings, his soul, and his music.

And then the viewer was treated to him singing one of his original compositions celebrating himself.

Once upon a time your 'umble scrivener watched in fascinated horror as a king snake fought and then devoured a rattlesnake while the rattlesnake was still alive.

The purported musician's performance was rather like that, so whiney-nasal in the vocalization, so self-obsessed in the lyrics, and so brutal in the abuse of the chords and the poor guitar that the interest was in how awful (not awesome) an exhibition of narcissism could be.

But, hey, there were thousands of InterGossip hits (sic), so the music was aesthetically pleasing to some.

When the unhappy noises were ended and the segment was closed with the usually filler-language praising this, oh, experience, the thoughtful observer could only note that the redeemed never expressed any

concern about those whom he had hurt.

There was a too-common catalogue of crimes in this young person's life, according to the interviewer, one of which including breaking into an elderly woman's house and robbing her.

The inspirational singer-songwriter never mentioned her or any of his victims. He made no apologies, he never expressed any regret, he never suggested in any way that he had broken the norms of civilized behavior. He never mentioned having a job

Common generational snobbery would dismiss this self-obsessed young person as a millennial, ignoring the salient fact that the good a man does, or the evil that a person does, is not connected with the date of birth. The reality that most folks born between 1983 and 2001 – the much maligned millennials – now form the

core of this nation's military, police and fire services, medical professionals, and work force. Passing on clichés about millennials is a disservice to our concepts of honor and honesty – after all, almost all our fine young men and women fighting in the deserts are (gasp) millennials.

And, after all, self-obsession is not defined by date of birth; a individual chooses to grow up and kinda / sorta try to act like a man, or his can just sit around and feel sorry for himself.

The first-person voice is sometimes necessary for advancing a narrative, but it is a risky thing to do.

Even so, one would like to hear more first-person voices from those who have done hard time in Afghanistan or with the police or fire services, and not from those who have enjoyed the leisure to learn the guitar on the taxes and labor of those in Afghanistan (did you know that a soldier's combat pay is taxed?), the fire and police services, and in the sweat of honest work.

FOREIGN CYBER ACTORS TARGET HOME AND OFFICE ROUTERS AND NETWORKED DEVICES WORLDWIDE SUMMARY

The FBI recommends any owner of small office and home office routers power cycle (reboot) the devices. Foreign cyber actors have compromised hundreds of thousands of home and office routers and other networked devices worldwide. The actors used VPNFilter malware to target small office and home office routers. The malware is able to perform multiple functions, including possible information collection, device exploitation, and blocking network traffic.

TECHNICAL DETAILS

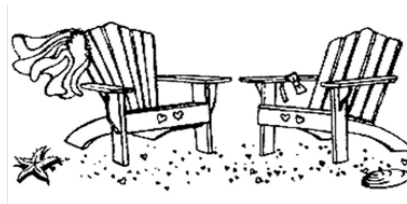
The size and scope of the infrastructure impacted by VPNFilter malware is significant. The malware targets routers produced by several manufacturers and network-attached storage devices by at least one manufacturer. The initial infection vector for this malware is currently unknown.

THREAT

VPNFilter is able to render small office and home office routers inoperable. The malware can potentially also collect information passing through the router. Detection and analysis of the malware's network activity is complicated by its use of encryption and misattributable networks.

DEFENSE

The FBI recommends any owner of small office and home office routers reboot the devices to temporarily disrupt the malware and aid the potential identification of infected devices. Owners are advised to consider disabling remote management settings on devices and secure with strong passwords and encryption when enabled. Network devices should be upgraded to the latest available versions of firmware.

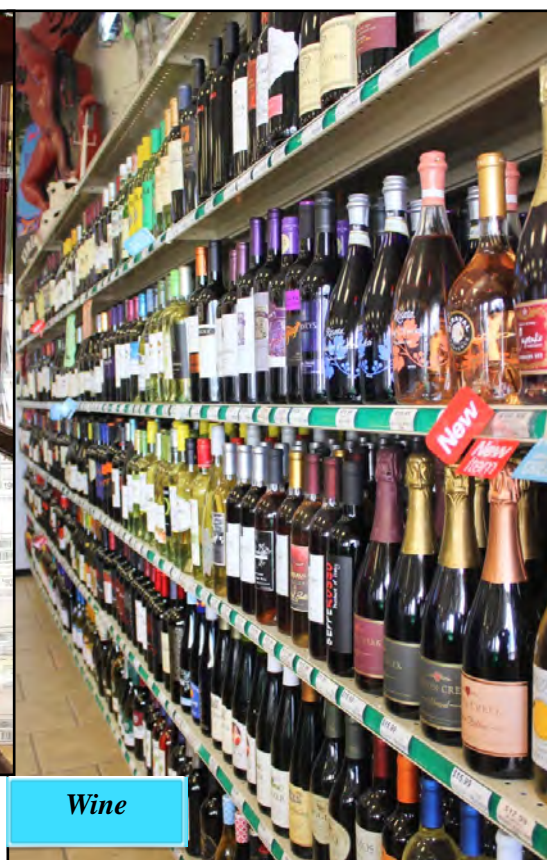

[1][2][3] At the time, anti-coalition militia activity in the region was carried out most notably by a small group led by a local man from Nangarhar Province, Ahmad Shah, who had aspirations of regional Islamic fundamentalist prominence. He and his small group were among the primary targets of the operation.

It utilized special operations forces (SOF) units and assets, including members of the U.S. Navy SEALs and the U.S. Army Special Operations Command's 160th Special Operations Aviation Regiment (Airborne) (SOAR(A)), for the opening phase of the operation.[2] A team of four Navy SEALs, tasked for surveillance and reconnaissance of a group of structures known to be used by Shah and his men, fell into an ambush by Shah and his group just hours after inserting into the area by fastrope from an MH-47 helicopter.[2] Three of the four SEALs were killed, and a quick reaction force helicopter sent in for their aid was shot down with a rocket-propelled grenade fired from an RPG-7, killing all eight U.S. Navy SEALs and all eight U.S. Army Special Operations aviators on board.

The operation then became known as "Red Wings II" and lasted approximately three more weeks,[1][2] during which time the bodies of the deceased SEALs and Army Special Operations aviators were recovered and the only surviving member of the initial team, Marcus Luttrell, was rescued.[6] While the goal of the operation was partially achieved, Shah regrouped in Pakistan and returned with more men and armament, aided by the notoriety he gained from the Red Wings ambush and helicopter shootdown. Several weeks later, Shah's group in Kunar Province was stricken to a point of inoperability and Shah was seriously wounded, during Operation Whalers in August 2005.

Keep Bolivar Beautiful again held its 20' x 30' American flag to honor those in the Kilo 19 - A Walk to Remember as part of Memorial Day.

KBB was honored to have Arlington City Council Member Roxanne Armistead Thalman and her daughter Ava join us in holding the flag.

Roxanne, an Air Force veteran, is a direct descendant of George Armistead, who was commander at Ft. McHenry during the Battle of Baltimore which inspired Frances Scott Key to write the poem that later became "The Star-Spangled Banner."

When he arrived at Fort McHenry, located in the outer harbor of Baltimore, Armistead ordered "a flag so large that the British would have no difficulty seeing it from a distance." That flag, known as the Star Spangled Banner, measured 42' x 30'.

During the nearly 25-hour bombardment of Fort McHenry, commencing before dawn on Sept. 13 until the morning of Sept. 14, 1814, Armistead alone knew the fort's magazine was not bombproof. When a shell crashed through the roof of the magazine but failed to explode, Armistead ordered the powder barrels cleared out and placed under the rear walls of the fort. Remarkably, only four men were killed, when two shells smashed into the fort's southwest bastion, despite a deadly rain of some 2,000 mortar shells that the British bombardment fleet fired at the fort. Because the Royal Navy proved unable to capture or reduce the fort in order to enter Baltimore harbor to bombard the main American defense line east of the city, British commander-in-chief Vice Admiral Sir Alexander Cochrane wrote to British Army commander Col. Arthur Brooke that it was up to him whether to decide to attack or withdraw.

Brooke decided to withdraw.

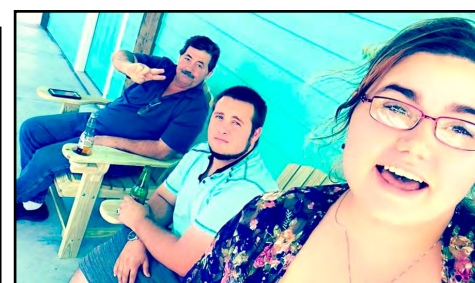

I was disappointed in Esperanza (yellow bells), one of my favorite flowering shrubs. Mine were still in pots so more vulnerable than plants established in the ground. Esperanza was one I always recommended for Bolivar Peninsula because of their impressive blooming period. I now have reservations after last winter's devastation. I liked pairing Esperanza with Duranta (golden dewdrop). Duranta had me anxiously awaiting a comeback but they finally came through. Duranta remains on my recommendation list.

Spring was interesting this year waiting and watching to see what plants that looked doomed would come back to life. I lost a few plants my biggest disappointment was losing the Hummingbird trees I grew from the seeds I had from the tree that froze the prior year, I guess those beauties are just not meant to be on our subtropical climate peninsula. I am very excited as many plants did come back to life and are more beautiful than they were before!

The Bolivar Beach Bloomers was unable to have our plant sale in April as planned at the Eagles but we plan on having one June 16 at the Eagles Market. Come by and check out what we have you may find something that will interest you!

Ange's Corner Monthly Tip: Hydration

Especially in summer I'm reminding WATER LONGER, DEEPER, LESS OFTEN. Don't rely on lawn sprinklers to water shrubs & trees. Shallow watering encourages shallow roots. Trees with shallow roots blow over in wind events. I make a little moat around trees and shrubs to keep water from running off, at least until well established with DEEP ROOTS. Patience and generosity in watering plants new to the ground pays off with healthy plants that require less watering in the future. A slow drip can be most effective to be sure water is soaking down deep. Let the surface soil dry out in between watering. Once a week deep watering is better than more frequent shallow watering.

We get excited when we get a little shower here in this savanna desert! Don't assume a little rain is adequate for plant roots. A good test is to look at a shovel load of soil to see how deep the water did reach. Substantial rain can run off dry soil leaving roots still parched. Mulch is very helpful in preventing runoff, retaining moisture and adding nutrients as it breaks down.

Even with adequate hydration our wind and long sunny days are a challenge for new plants in the summer. If you can resist spring/summer planting, fall planting is ideal. I still plant any time of year but know it is a commitment to water deep all summer long!

Apology to 'the choir': I preach plant hydration repeatedly! I will continue the sermon as long as I keep encountering thirsty plants. Sing along with me!

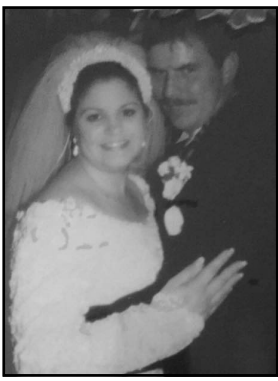

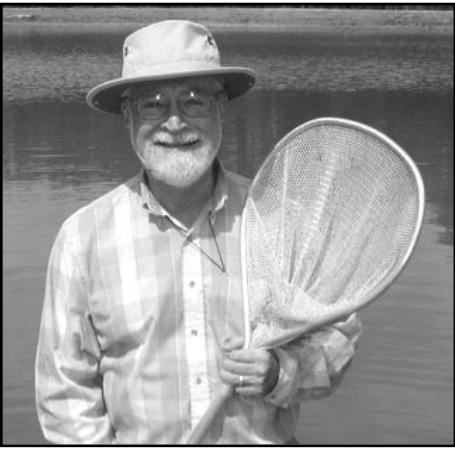

Barnacles

Can you imagine giving up a life of freedom to deliberately glue your head to a cement wall and live upside down, kicking food into your mouth with your feet? Yet, this bizarre life is just what barnacles—those familiar creatures which encrust jetties, pilings, and oyster reefs with their teepee-like shells--do.

Barnacles are not mollusks, like the limpets which often share space with them, but are actually crustaceans. Their characteristic, lime-reinforced shells consist of overlapping plates, the shape and sculpturing of which supply identification clues to the scientists who study them. None other than the famous British naturalist Charles Darwin became a student of barnacles, choosing them as a way to teach himself the intricacies of biological classification.

The familiar substrate-encrusting barnacles are important elements of the rocky seashore and oyster reef communities of the Texas coast. In this column I will deal with four common types: the giant offshore barnacle (*Balanus tininnabulum*); the striped barnacle (*Balanus amphitrite*), the much smaller jetty barnacle (*Chthamalus fragilis*), and the oyster reef or acorn barnacle (*B. eburneus*). Another group of barnacles, the stalked or gooseneck barnacles (*Lepas* spp.), are such different animals that I will treat them in another column.

The giant offshore barnacle's clustered shells, usually colored a lovely rose and white, often wash up on shore after storms. Cleaned, dried and varnished specimens are popular as curios. Already-cleaned specimens can be purchased at shell shops, but beachcombed shells can be soaked in fresh water for several days and then laid near ant mounds in a shaded place to let the ants clean them out. Giant offshore barnacles commonly attach themselves to oil rigs and the deepest parts of jetties, their shells forming additional substrate. Even when dead, their remains form tiny caves that shelter numerous organisms.

Wooden pilings and jetty stones on the surf side of the beach often have two species of barnacles at different levels: the smaller *C. fragilis* on the upper portions and the much larger, prettily-striped *Balanus amphitrite* on the lower. This habitat is one of the few places on the Texas coast where zonation is easily seen. *Chthamalus* barnacles seem to prosper by themselves where their colonies are exposed to the air much of the time, perhaps because one of their chief predators, the rock snail *Stramonita haemastoma*, cannot reach them there. The much larger and more snail-resistant *B. amphitrite* flourishes on the deeper, rarely- or never-exposed portions of the piling or stone,

along with a rich assembly of organisms such as hydroids and bryozoans.

In lower-salinity habitats such as bayside oyster reefs, the acorn barnacle (*B. eburneus*) makes its home on dead and living shells, particularly oysters (*Crassostrea virginica*) and hooked mussels (*Ischadium recurvens*). These barnacles and the rest of their substrate are usually covered with a greenish slime of algae, making human footing treacherous. Of the barnacles discussed in this column, *B. eburneus* tends to form more dispersed colonies where the individuals may actually be slightly spaced. While large predatory snails are usually absent from these brackish habitats, several types of shore crabs make meals out of the young barnacles, which may help explain their spaced distribution.

Barnacles begin life as tiny one-eyed planktonic larvae called nauplii. Barnacle nauplii resemble those of some shrimps, suggesting that barnacles share a common ancestor with them. Barnacle nauplii float in the plankton for several weeks, feeding on smaller plankton and dispersing around the world. After six molts, the nauplii change to a larger, more seedlike form called a cypris. Eventually, the cyprii leave the plankton and settle on suitable substrates. Studies have shown that this settling is not random; cyprii are attracted to already-established colonies and tend to settle there. This behavior is driven by the need to be close to other

barnacles, for unlike many sea creatures barnacles must have contact with one another to mate.

Once settled, the cyprii cement themselves to the substrate with glands found on their antennae. Soon, the familiar teepee shape of a tiny barnacle appears. The barnacle's "feet", once feathery appendages used for swimming, are pushed out between the two opposing plates at the shells' apex to ensnare food particles and transport them to the mouth. For the rest of its life the barnacle will remain there in this position, sealing its entrance when the tide goes out and resuming feeding as soon as the shell is covered again with water.

Because a settled barnacle is unable to leave its attachment site and because it must mate with another individual (both sexes are present in the same animal, but it must mate with another), relative to their size nature has endowed barnacles with the longest sex organs of any other creature. When the eggs of one individual are ripe, chemical signals induce the others in the colony to seek out the signaler with their organs and deposit sperm into its brood cavity, sometimes from over an inch away!

In the sea, a style of life that is scarcely possible

on land is widespread: one can be cemented forever in one spot, waiting for the sea to bring its food. For barnacles, what seems a fantastic way of life for us is just everyday existence—and has made barnacles a great evolutionary success story all over the world.

May has come and gone. It was an awesome month of catching, with tons of big trout being caught almost anywhere that your lure would land. There were tons of bait fish spawns all month long resulting in copious amounts of bait all throughout the bay. The catching was great on the days that allowed and the fishing hard on other days.

Looking to the future for East Bay, June looks to be a promising month as the bait grows and becomes less and less prominent. The mid-bay reef systems will begin to become a solid producer with the warming water. Recently the water has been holding in the mid-eighties and in the upper eighties in the marshes. Look to start the traditional warm weather pattern of wade fishing early and late and drifting reefs in the middle of the day.

Reports from West Bay have been of solid consistency, fishing West Bay will be a lot like fishing in East Bay, wading in the morning and drifting in the afternoon. Trinity Bay has made a solid come back after the deluge of fresh water. Reports of solid Gulf Trout have been coming off the rigs close to the Houston Ship Channel.

The surf should start to turn on with the push of better water coming in close to the beaches. Remember, no matter where you decide to wade, wear your lifejacket at all times, use safety precautions, and be aware of your surroundings! Hurricane Preparedness

Build A Kit

Make sure your emergency kit is stocked with the items on the checklist below. Most of the items are inexpensive and easy to find, and any one of them could save your life. Headed to the store? Download a printable version to take with you. Once you take a look at the basic items, consider what unique needs your family might have, such as supplies for pets, or seniors.

After an emergency, you may need to survive on your own for several days. Being prepared means having your own food, water and other supplies to last for at least 72 hours. A disaster supplies kit is a collection of basic items your household may need in the event of an emergency.

Basic Disaster Supplies Kit

To assemble your kit, store items in airtight plastic bags and put your entire disaster supplies kit in one or two easy-to-carry containers such as plastic bins or a duffel bag.

A basic emergency supply kit could include the following recommended items:

- * Water - one gallon of water per person per day for at least three days, for drinking and sanitation
- * Food - at least a three-day supply of non-perishable food
- * Battery-powered or hand crank radio and a NOAA Weather Radio with tone alert
- * Flashlight
- * First aid kit
- * Extra batteries
- * Whistle to signal for help
- * Dust mask to help filter contaminated air and plastic sheeting and duct tape to shelter-in-place
- * Moist towelettes, garbage bags and plastic ties for personal sanitation
- * Wrench or pliers to turn off utilities
- * Manual can opener for food
- * Local maps
- * Cell phone with chargers and a backup battery

Additional Emergency Supplies

Consider adding the following items to your emergency supply kit based on your individual needs:

- * Prescription medications
- * Non-prescription medications such as pain relievers, anti-diarrhea medication, antacids or laxatives
- * Glasses and contact lens solution
- * Infant formula, bottles, diapers, wipes, diaper rash cream
- * Pet food and extra water for your pet
- * Cash or traveler's checks
- * Important family documents such as copies of insurance policies, identification and bank account records saved electronically or in a waterproof, portable container
- * Sleeping bag or warm blanket for each person
- * Complete change of clothing appropriate for your climate and sturdy shoes
- * Household chlorine bleach and medicine dropper to disinfect water
- * Fire extinguisher
- * Matches in a waterproof container
- * Feminine supplies and personal hygiene items
- * Mess kits, paper cups, plates, paper towels and plastic utensils
- * Paper and pencil
- * Books, games, puzzles or other activities for children

Maintaining Your Kit

After assembling your kit remember to maintain it so it's ready when needed:

- * Keep canned food in a cool, dry place
- * Store boxed food in tightly closed plastic or metal containers
- * Replace expired items as needed
- * Re-think your needs every year and update your kit as your family's needs change.

Kit Storage Locations


Since you do not know where you will be when an emergency occurs, prepare supplies for home, work and vehicles.


Home: Keep this kit in a designated place and have it ready in case you have to leave your home quickly. Make sure all family members know where the kit is kept.

Work: Be prepared to shelter at work for at least 24 hours. Your work kit should include food, water and other necessities like medicines, as well as comfortable walking shoes, stored in a "grab and go" case.

Vehicle: In case you are stranded, keep a kit of emergency supplies in your car.

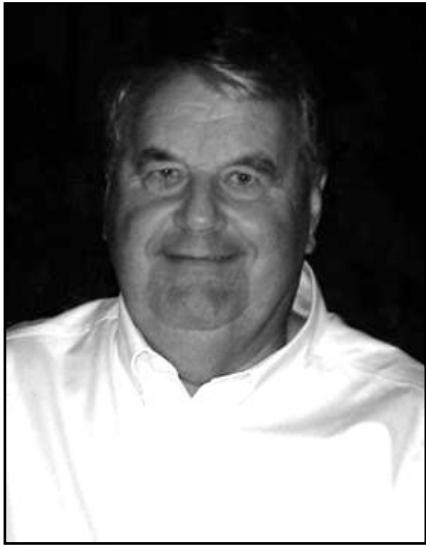

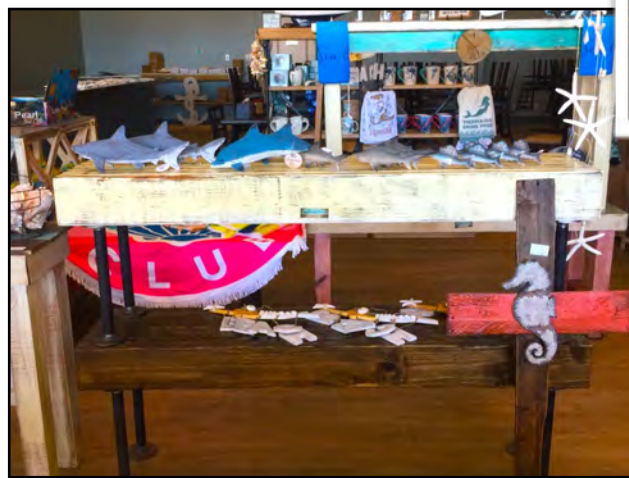
