# Texas Crab Festival Finds New Home New Venue Offers Expanded Opportunities

The Texas Crab Festival has announced plans to kick off the 34th annual celebration of Gulf Coast style Music, Art and Crabs with an exciting change of venue. The 2019 Texas Crab Festival opens Friday, May 10, 2019 at its new permanent home at 1605 Highway 87 in Crystal Beach, and runs through Sunday, May 12, 2019.

The new site, now named "Festival Park" sits on 51 acres formerly occupied by Texas Frog Fest, and features a huge performance stage, dedicated dance floor, beer garden, and plenty of room to grow. The Crab Fest makes the move from Gregory Park, its home since the festival began in 1985. The new location provides expanded growth opportunities for Texas Crab Festival Charities 501(c)3, which gives 100% of net proceeds from the festival back to the community in the form of scholarships, job training, youth camps and initiatives for residents of Bolivar Peninsula.

All the traditional Crab Fest favorites will still be on board – Texas Crab Festival 5K Run, Crab Gumbo Cook Off, Crab Legs Contest, Weiner Dog Races, tournaments, contests and games; Carnival midway, RV and Boat shows. Sample tasty crabby creations and local seafood favorites from a variety of vendors while browsing booth after booth of coastal arts and crafts, gifts, beach wear and décor.

2019 music entertainment headliners Wayne Toups, Sunny Sweeney, Bag of Donuts and Sandy G y los Gavilanes take the new main stage along with Paul Childers, Tennessee Jet, Andy & the Dreamsicles, Treble Soul, The Cadillacs, Haley Comeaux, Heaven's Love, and the Bolivar's Got Talent Show. Keep the little ones entertained with Crab Races, games at the Crab Arcade, carnival rides, and fun activities at the Kid's Stage.

The Texas Crab Festival runs May 10-12, 2019. Tickets are \$10 for Friday or Saturday admission; kids 15 and under are free.. Everyone gets in free on Sunday, and parking is free all weekend. Carnival ride wristbands are halfprice at \$10 on Sunday.

# U.S. Attorney Warns of Potential Charges for Interfering with NTSB Investigation

HOUSTON – Anyone that knowingly removes, conceals or withholds a part of a civil aircraft involved in an accident could face civil penalties, criminal charges or both, announced U.S. Attorney Ryan K. Patrick.

According to the National Transportation Safety Board (NTSB), Atlas Air Flight 3591 left Miami at 11:30 a.m. Eastern time Saturday, Feb. 23, bound for Houston. At approximately 12:40 p.m., the twin-engine Boeing 767 cargo jetliner crashed into Trinity Bay near Anahuac.

The FBI has urged anyone with information, photos or videos regarding the incident or with knowledge of debris from the crash to call 1-800-CALL-FBI.

"It should be obvious to everyone, but do not pick up or remove pieces of the wreckage. It can interfere with the investigation and could lead to criminal charges," said Patrick. "If you do come across debris on your property, please contact the FBI. Additionally, the NTSB and FBI have asked that area residents and businesses check security cameras for possible video of the crash."

It is a federal crime to withhold part of a civil aircraft involved in an accident. If convicted of knowingly and without authority removing, concealing or withholding a part of such an aircraft, or property on the aircraft at the time of the accident could face up to 10 years in prison, if convicted. The charge could also carry a fine of up to \$250,000.

The NTSB is leading the investigation with cooperation and assistance from FBI, Texas Parks and Wildlife, Texas Department of Public Safety, sheriff's offices in Chambers and Harris Counties and the Houston Police Department, among others.





### An open letter to the Bolivar community:

As you may have heard, the 2019 Texas Crab Festival will be moving from its long-time location at Gregory Park to a new permanent home at 1605 Hwy 87, former site of the Texas Frog Festival. Along with the congratulations that followed that announcement were a number of questions and concerns voiced from the community, which I would like to address here.

The first question many are asking is why we've decided to relocate the Texas Crab Festival from Gregory Park – its home since it began in 1985. What began as the brainchild of a group of Bolivar friends and business people looking for a fun way to promote the area has grown into an annual event pulling in over 8,000 visitors over the course of a Mother's Day weekend. Through the tireless efforts of countless volunteers and supporters the festival has continued to expand, and so too have the demands for visitor parking and accommodations.

In a happy twist of fate, just as the Crab Fest was facing additional challenges with an aging pavilion and the loss of surrounding areas used for parking to new home development, the former site of the Texas Frog Fest became available for purchase. The non-profit Texas Crab Festival Charities was offered the opportunity to obtain the property at a discounted price, and a generous, private investor who believes in our mission to serve and support the Bolivar community provided long-term, no-interest financing. The 51-acre site, now dubbed "Festival Park," features a larger, better equipped performance stage, a dedicated dance floor, beer garden, ticket booth, skybox viewing stands, increased parking space, and plenty of room to grow. It is our intention that Festival Park will eventually become a "community park," hosting a variety of events throughout the year in addition to the annual Texas Crab Festival.

Some of the concerns I'm hearing stem from muddy memories of the site during the early days of the Texas Frog Fest. Access, parking and site elevation have been much improved over the years. The need for further improvements is being accessed and addressed as we make plans to kick off the upcoming 2019 Texas Crab Festival in the new location, May 10-12.


Another issue is the lack of golf cart access to the new site. True, we will now be located on the north side of the highway, and there are no cross streets nearby. We are looking into possibilities for visitors wishing to travel to and from the site via golf cart, and hope to eventually have a solution.

Lastly, folks are wondering if the Texas Crab Festival 5K/1K race will be relocated as well. As of now, the race will continue to be held at the original location of Gregory Park and its surrounding neighborhood. It is a familiar, certified course, and at this point we do not have time to lay out and certify an alternate course. Racers will still receive a ticket to the festival with their registration.

While the move will have its challenges, this is a very exciting opportunity for Texas Crab Festival Charities to grow the Crab Fest. Texas Crab Festival Charities is a 501(c)(3) nonprofit that serves to improve the lives of those who call the Bolivar Peninsula home. Since its creation in 2013, TCFC has awarded almost \$400,000 to help support local residents and organizations. Proceeds from the annual Texas Crab Festival and donations from our patrons are reinvested in the community and help fund youth scholarships and camps, local schools and volunteer fire departments, and various outreach initiatives.

We value the insight, input and support of the Bolivar community and all of our faithful festival patrons as we work to build a permanent home for the Texas Crab Festival and continue our mission to "Turn the Tide for a Brighter Future" for residents of the Bolivar Peninsula.



Minutes of the Regular Meeting, January 8, 2019

Directors Present: George Strong, Vice President; Chris Makin, Treasurer; Wayne Turk; Kurt Ploeger DJ Hutchinson Hollis Gassen, President Maria Skewis, Secretary

Staff Present: Jo E. Ball, General Manager: Donald Crawford, Field Manager; Clifford Howard, Plant Manager

#### Others Present:

Item 1 Call to Order: At 6:00 PM President, Hollis Gassen, declared a quorum present and called the meeting to order.

Item 2 Pledge of Allegiance and moment of silence: The Pledge of Allegiance was led by Mr. George Strong and cited by all present. Afterwards, a moment of silence was observed.

Item 3 Approve minutes of the December 11, 2018 General Meeting: A motion was made by George Strong and seconded by Kurt Ploeger to approve the December 11, 2018 minutes as presented. Motion unanimously passed.

Item 4 Committee Reports: Audit & Finance: Wayne Turk reported the Audit and Finance Committee had met earlier today and reviewed the District's invoices, check registers, investments, and bank statements for December and found everything to be in order.

Item 5 Public Comments: There were no public comments.

Item 6 Manager's Report: The manger's report was presented by Mr. Jody Ball and the following items were 5) Personnel: One new employee reported and/or discussed:

- 1) A Review of Trial Balance, Comparative Budget Report and Account Balance Summary List: The Board reviewed the Trail Balance Report, Comparative Budget Report and the Account Balance Summary through December and found everything to be in order.
- Review System Operational Reports:
- District Water Losses. The District experienced a four-month average water loss through December of 5% and 18.6% loss for the month.
- The District has 5099 active accounts through December. In December, 2 accounts were liquidated and 57 were shut-off for non-payment.
- \* Total water sales for December were \$278,159.00.
- \* Average monthly water bill for December was \$60.18 and for 2018 the average was \$62.00.
- \* Water pumped was 22.5M gallons and water sold was 9.5M gallons with a loss difference of 13.0M gallons. There was 1 leak repaired.
- \* There was 0 reportable accident/ incident for the month.
- 3) Review current infrastructure projects: Discussions continue with TXDOT on options for relocating the District's 20" main line at highway 124 and 87 intersection. The District is in discussions with GLO on a new water tower project with additional information to be provided.

- 4) Rollover Pass: There is no additional information available.

- 6) Finances: Net income for December was \$69.759.

Item 7 Consideration and possible action to approve Health Insurance for 2019: The Board reviewed a proposal for an employee UTMB Health Multi-Share Plan. Further information is needed. This item is tabled until the February meeting.



The Chamber will also be looking into and forming committees to sponsor some special events here. Individual membership is \$12.50 per year.



### Mosses, Back of the Beach Part 2 **Becoming a Moss Collector**

Last month we took a look at one of the most fascinating but little-known groups of plants that a naturalist might encounter in Texas coastal environments: the true mosses. "Littleknown" is actually a misnomer, because in other parts of the world (particularly Europe) mosses have been extensively collected and studied for several hundred years. Happily, much of the knowledge obtained by hard-working European naturalists and botanists has spilled over into North America, since many moss species can be found in both places due to their use of spores for dissemination. In this column, I'll talk about collecting and examining mosses, with the view of starting your own collection.

Unlike many natural objects such as flowers, insects, and birds, mosses have several tremendous advantages for a collector. There are almost no regulations (other than property rights) for collecting them, quite unlike birds which enjoy both federal and state legal protection that limits their collection by amateurs to picturetaking. Mosses can be dried and stored in small paper envelopes (I use coin envelopes) that take up almost no space; you can store a large collection in a shoe box. Mosses are almost completely immune to the biological agents such as moths, mold, and silverfish that can quickly destroy regular botanical or insect collections. As long as they are kept dry, they will last basically forever. When needed for examination, a small piece of a dried moss can be rehydrated in hot water. In a few moments it will be as almost as useful as when fresh.

In the beginning, it is a good idea to limit your collections to palm-size patches of moss that have mature spore capsules growing out of them. These capsules are borne on stalks called setae and look like tiny street lamps sticking up from the green moss "bed". Mosses that lack these structures are referred to as "sterile"

and are often very difficult to identify, even by experts. In many cases, you will find two or more species of moss growing together that are distinguishable by having very different capsules.

Always write down the state, county, nearest city, and habitat notes of any species you collect directly on the envelope. Add the date and your name, and you'll have a properlylabeled field collection. The actual collection process will be aided if you can scrape the moss away from its substrate with an old butter knife so as to bring over as little of the soil or tree bark as possible.

Some moss should always be put into a jar for observing while alive. I like to use hand-size jars like the ones used to package party dips and okra pickles—always plentiful in my family! Many species will continue to grow for long periods in such a micro-terrarium if a thin, moist layer of the original substrate in included with the collection. By doing this, collections that have green, immature capsules will often mature to the point where their identification becomes easier.

As I mentioned last month, while much can be done with a good hand lens, you will eventually want to acquire a compound microscope if you want to identify mosses. These are no longer prohibitively expensive and can often be purchased second-hand in good condition. I prefer the nostalgic look, excellent optical quality and mechanical sturdiness of the older brass medical microscopes such as the Bausch & Lomb and Spencer Optical 1918 models. However, these require an outside light source and do not usually come with a scanning, or 4X, lens which is one of the more useful magnifications. If you are unfamiliar with microscopes you may want to visit a nearby college science department and get some hands-on advice from a friendly biologist before investing in one.

Some moss collectors are less interested in making collections of dried moss than they are of making moss gardens. While this is a fascinating branch of horticulture that has great potential for enlarging our understanding of moss growth requirements, be warned that most mosses are rather picky about where they will live and may not thrive if transplanted to a site where the substrate, moisture, and light conditions are not just right. Contact a Texas Master Gardener for more help on this interesting sideline.

In my column last month I mentioned a few older books that will help you in moss lore and

identification. Probably the best for a beginner is H. S. Conrad's How to Know the Mosses and Liverworts (Wm. C. Brown, 1956), which is full helpful illustrations and techniques for preparing mosses for examination under the microscope. If you can find one, another must-have book is A. J. Grout's Mosses with a Hand Lens, 2nd or 3rd edition (1924—try to get an original, not a facsimile reprint). Once you begin to examine the beautiful structures that moss plants have, especially the capsule and its fascinating mechanisms for letting the spores out only a few at a


he'll try to answer them.

Mosses grow anywhere there is enough moisture and (usually) subdued light to sustain them. However, it will not be long before you find yourself "stumped" on the identification of what may be a very common moss that grows all around you. A good place to look for someone who can help is the website of the American Bryological and Lichenological Society. This organization is one of the oldest biological associations in America and can take you as far as you wish to go. Good luck exploring in the fairyland of the mosses!



### **Help with Unpaid 2018 Property Taxes**

February delinquent notices arrived in area mailboxes last week. Thanks to legislation passed several years ago, homeowners unable to pay their property taxes in full may sign up for a low penalty payment agreement with the tax assessor collector. Additionally, qualified seniors, disabled persons, disabled vets, spouses of disabled vets and those still recovering from Hurricane Harvey may pay 7% penalty and interest on one-fourth of the 2018 levy by February 28th and sign up for quarter installment payments.

For those paying the 7% penalty and interest to establish quarter installments and those whom have already paid at least one-fourth, the remaining three coupons and return envelopes will be mailed within the next two weeks. The second installment must be postmarked by April 1, third by May 31 and final one-fourth by July in order to be timely.

Property owners may pay in person at GCTO branches in Galveston, League City, Santa Fe and Texas City Monday through Friday 8:00 to 5:00 and in Friendswood Thursdays and Fridays (closed Noon to 1:00 for lunch). Yellow payment drop boxes are located all full time locations and payments are retrieved at 8:30 am daily (and stamped received the previous business day). A black payment box is also located at the back of the side driveway at Friendswood City Hall.

Payments may also be made online (www.galcotax.com) via electronic check (\$1 fee) or credit card (2.5% fee) or through Chase Bank's Payment Processing Center via telephone at 1-866-865-1433 (English) or 1-866-865-1435 (Spanish). If online banking is your preferred method of payment, expect a 3-5 day delay for paper check to be prepared and mailed to our office which could result in penalty and interest if the bank does not prepare the check the same day.

Those with property tax questions or concerns should call the Property Tax Department directly at (409) 766-2481 (or call the toll free number and ask for a Property Tax Specialist). 



### Cooking with Miss "Obler"

Janice Oliver, Retired Home Ec Teacher, HIISD

We often get blueberries, frozen sweetened strawberries, and a variety of meats at Food Fair. This month I want to share with you recipes that use some of these wonderful food items.

#### THE BEST SLOW COOKER **PULLED PORK**

4 pounds pork shoulder 2 tablespoons paprika

(Try smoked paprika for more of that smoked flavor)

2 tablespoons brown sugar

1 teaspoon pepper

1 teaspoon cayenne pepper

1 teaspoon garlic powder

1 teaspoon onion powder

1 teaspoon kosher salt

1/4 cup apple cider vinegar

3/4 cup water

Mix together all of the dried spices and rub into all sides of the pork.

Place vinegar and water in bottom of slow cooker.

Carefully add pork (so you don't wash off spices).

Cover and cook on low for about 8 hours.

Remove pork and shred (Remove any large fatty acids and discard).

Add juices from slow cooker as desired.

#### Notes:

Tip 1: Save a bit of seasoning and toss it with cooked pulled pork to add extra kick (but just a tad, you don't want to ruin the delicious flavors of the meat).

Tip 2: If you want brown crispy ends you can put shredded meat on foil lined baking sheet and broil for a couple of minutes in the oven (watch carefully).

#### **PULLED PORK SHEPHERD'S PIE**

5-6 cups pulled pork 2 cups barbecue sauce 1 cup frozen peas 1 cup frozen corn 3-4 pounds potatoes 2 tablespoons butter

1/4 cup milk

1 1/2 cups grated cheddar cheese

Preheat oven to 350 degrees.

Peel potatoes and, if they are large, cut in half. Place in a pot and fill with water. Boil until tender. Drain the water. Add the butter and milk to the potatoes. Mash until the potatoes are creamy.

Toss pulled pork with barbecue sauce until evenly coated. Spread on the bottom of a 13" x 9" baking dish (lasagna pan).

Sprinkle frozen peas and corn on top of the pork.

Spread the mashed potatoes on top of the frozen vegetables.

Top with grated cheese.

Bake in the oven for 45-60 minutes. The cheese should be starting to grown and some barbecue sauce should be bubbling up the sides.

#### **BLUEBERRY ICE CREAM**

2 cups blueberries (picked, rinsed, and drained)

3/4 cup sugar

1 cup half-and-half or whole milk

2 cups heavy whipping cream

Freeze ice cream bowl for 24

Combine blueberries and sugar in a medium sized sauce pan over medium heat. Do not cover but mashed blueberries with spatula and stir until sugar dissolves, about 5 minutes.

Remove from heat and pour into a large bowl. Stir in half-and-half and cream. Cover and refrigerate for at least 2 hours.

Place frozen bowl on base of ice cream maker and turn it on. Pour chilled mixture into frozen bowl and churn until desired consistency, about 15 to 20 minutes.

If you prefer a firmer consistency, transfer ice cream to a container and place in freezer for a couple of hours.

#### **BLUEBERRY MUFFIN BREAD**

1 cup white sugar 1/2 cup salted butter

2 eggs

1 tablespoon vanilla extract

1 cup milk

2 cups all-purpose flour

2 teaspoons baking powder

2 cups blueberries

Preheat oven to 350 degrees. Grease a 9-inch loaf pan.

Cream together the butter and sugar.

Add the eggs, vanilla and milk beating well.

Add the dry ingredients and beat until well combined.

Add blueberries and mix by hand gently with a spatula being careful not to crush the berries. Pour batter into your loaf pan and bake for 60-75 minutes or until a cake tester (toothpick) comes out clean.

Allow to cool in pan for 10 minutes before removing to finish cooling. Note:

Reserve a small handful of blueberries for after the batter is poured into the loaf pan.

Gently press them into the top to make the loaf look prettier.

#### **LEMON BLUEBERRY PULL-APART BREAD**

1/2 cup granulated sugar 1/4 cup butter, melted zest of 1 lemon

1 - 16 ounce tube refrigerated biscuits (like Pillsbury Grands Flaky Honey

1 cup fresh or frozen blueberries

#### FOR GLAZE:

zest of 1 lemon juice of 1 lemon

1/1/2 cups - 2 cups powdered sugar **INSTRUCTIONS FOR BREAD:** 

In a large bowl, stir together sugar, butter, and lemon zest.

Cut each biscuit into 4 pieces.

Toss the biscuit pieces with the sugar mixture.

Spray a 9-inch round cake pan with cooking spray.

Scatter half the blueberries in the bottom of the cake pan.

Arrange the biscuit pieces in the cake pan.

Sprinkle with remaining blueberries. Bake at 400 degrees for 20-25 minutes, or until the edges are golden brown, and the center doesn't feel doughy when lightly pressed.

Remove from the oven, and immediately invert onto a serving plate.

#### **INSTRUCTIONS FOR GLAZE:**

In a small bowl, whisk together lemon zest, lemon juice, and 1 cup powdered sugar.

Depending on how juicy the lemon was, you may need more or less powdered sugar. Add enough that you have a thick glaze, but that it still drizzles.

Drizzle over the warm bread. Serve immediately.

#### STRAWBERRY BREAD

#### FOR THE BREAD:

3/4 cup granulated sugar 1/2 cup milk

1/2 cup oil

1 large egg

1 teaspoon vanilla or almond extract\*

2 cups all-purpose flour

2 teaspoons baking powder

1/4 teaspoon salt

2 cups diced strawberries (If you use the frozen sweetened, strawberries, just measure 2 cups.

Each container as 1/2 cup of strawberries, undrained) 2 tablespoons all-purpose flour

#### FOR THE GLAZE:

2 cups powdered sugar 2 tablespoons melted butter

1/3 cup finely diced strawberries (I measured 1/3 cup of the frozen, sweetened strawberries--the used the rest for a garnish on top of the glaze). 1/2 teaspoon vanilla or almond extract 1-2 tablespoons heavy cream or milk\*\* (optional)

#### **INSTRUCTIONS:**

Preheat oven to 350 degrees.

In a medium bowl, stir together the sugar, milk, oil, egg and vanilla. In a separate bowl, combine the flour, baking powder and salt. Add the fry ingredients to the wet ingredients and stir until just combined.

In a small bowl, toss together the strawberries and the 2 tablespoons of flour to coat the strawberries.

Fold the floured strawberries gently into the batter.

Pour the bread batter into a greased 9" x 5" bread pan. Bake at 350 degrees for 50-55 minutes. A toothpick inserted in the center of the bread should come out clean. Allow the bread to cool for 10 minutes, then remove the bread to a wire rack to cool completely.

To make the glaze, combine the powdered sugar, melted butter, diced strawberries and extract in a small bowl. Mix until it is smooth.

Once the bread is cool, spread the glaze on top of the bread. Slice and serve.

#### **NOTES:**

\*I always add double the amount of vanilla or almond extract to bread or cake batter (along with the wet ingredients) for an extra boost of flavor--especially if I am not putting the glaze on top. The bread has the most flavor when you use about 2 cups.

\*\*You may not need any milk or cream to make the glaze spreadable, depending on the juiciness of your strawberries. The glaze will be very thick and look like it is not mixing up. but if you need mixing, it should create a nice creamy pink glaze. If it doesn't, add milk or heavy cream 1 tablespoon at a time. The glaze will soften as it sits too since the sugar pulls out juices from the strawberries. If you use the frozen, sweetened strawberries, you probably won't need the milk at all and it will be a nice consistency).

### Hey, Hey, We're Monkees and Not Wagner!

February 21, 2019 a 77-year-old man named Peter Tork died. 77-year-old men have been known to die from time to time, but this man was quite famous in his youth as a member of the musical group The Monkees (sic) and continued to work until his death.

The Monkees were cobbled together in the 1960s by television producers as a weekly series to profit from the popularity of The Beatles (sic). A popular nickname for The Beatles was the fab four, and so a snarky nickname for The Monkees was the pre-fab four. And that was true enough, but the scheme became more popular than anyone imagined it would be, and The Monkees, through their popular television series, records, screaming-teenie tours, movies, and reunions, made themselves a significant cultural artifact.

Through a series of casting calls and tryouts four young men - Peter Tork, Micky Dolenz, Michael Nesmith, and Davy Jones - were hired to grow bowl haircuts and play the monkees in

the weekly series broadcast from 1965 - 1968. The producers employed the quick cuts, jerky movements, and minimal plotting of the Beatles' movies with great success. The WannaBeatles were harmless good fun with the assembly-line teenie-bop music put upon them, and for a while the world sang along to "Hey, Hey, We're the Monkees!"

Y'r 'Umble Scrivener remembers an occasion in the middle of the night when the jolly Viet-Cong treated us to their own special music, and among the racket (as with Wagner, the V.C. liked it LOUD), a friend's voice sang in a somewhat quavering but decidedly defiant counterpoint: "Hey, hey, we're the Monkees..."

Back in the U.S.A. the sometimes Fractious Four were musically ambitious and wanted to make more serious music that the programmatic tinkerty-tonk promoted for the show. They often did not get along with each other and they certainly did not get along with the men who made them

stars. Apparently none of their songs at that time featured gratitude as a topic.

Due to squabbles the show was canceled in 1968, and the lads continue to squabble as a group until 1971 when they pulled the metaphorical plug and pursued their own musical interests.

In the 1990s re-runs of the show on cable and satellite channels made The Monkees popular again, and for decades they made a number of reunion shows and fresh albums.

Y'r 'umble scrivener was vaguely aware of popular music only because he couldn't escape it in the a.m. radio subculture of the times, but could not distinguish The Monkees from The Beatles from The Eagles (let the reader react with shock and then disdain). Indeed, in his declining and / or golden years he has developed a fondness for German opera, and is happy to drive along to the tune of bellowing Wagnerians. His family is not happy about that, but his

dachshunds, being good Germans, are cool with all the sturm und drang.

However, success must be applauded, and musical people advise me that The Monkees aren't bad at all, and occasionally pretty good.

In sum, The Monkees were fun, and in a world where there is too much sadness, a bit of fun is good enough.

It is a truism that for those of a certain generation "I'm a Believer," "Last Train to Clarksville," "Pleasant Valley Sunday," and "Hey, Hey, We're the Monkees!" are essentials for the American road trip. For their grandchildren,

nah, that's MeeMaw and PawPaw music, and they retreat behind the cultural safety of their ear buds listening to God alone knows what beatnik-hippie stuff, eh?

# Beachcombing with Stefanie "Lionfish"

Recently Beckie Sosa and I found a Lion-fish washed up among the Hydrilla. Squealing with delight and curiosity, Beckie picked up the spiky fish while I snapped pictures.

The Lion-fish (pterois) is indigenous to the Indo-Pacific Ocean. It is ruby hued with long showy fins, stripped patterned, with venomous spines. It's a truly beautiful fish.

In the mid 80's, aquarium owners in Florida released Lion-fish into the Atlantic, after the ravenous beauties ate all the other fish in their tanks. From there, they took over the entire east coast of the United States, the Caribbean's and have made their way into the Gulf of Mexico.

These invasive predators have no natural enemies and an appetite for anything that swims. Their stomachs can extend up to 30 times their normal size to accommodate their unquenchable hunger. Lion-fish are known to eat up to 70 different species of fish, as well as crabs and shrimp. They are also known to be cannibalistic. A single Lion-fish can eat up to 5,000 fish per year, with a life span of 30 years.

Lion-fish have an insane reproduction fate. Females lay up to 30,000 eggs every 4-5 days or 2 million eggs a year.

If stung by a Lion-fish, soak the area in hot water for 30-90 minutes. The sting is extremely painful and can cause breathing problems which is when medical attention should immediately be sought.

Texas Parks and Wildlife urges fishermen **NOT** to release them if caught.

Lion-fish are delicious and easy to prepare, once the venomous spines have been removed with kitchen scissors.

#### **Broiled Lion-fish with Garlic and Basil Butter**

6 small Lion-fish fillets 2 Tbs melted butter Salt Pepper

Place fillets on lightly greased broiler pan. Brush with melted butter. Sprinkle with salt and pepper. Broil about 4 inches from heat until fish flakes easily with fork about 4.5 minutes. Some with

fork about 4-5 minutes. Serve with garlic basil butter. Serves 6

#### Garlic Basil Butter

1/2 c softened butter 1 tsp pressed garlic

1 tsp finely chopped fresh basil

1 tsp fresh lemon juice

1/8 tsp salt

In small bowl combine and mix all ingredients. Allow to stand 1 hour for flavors to develop. Spread over warm fillets.

#### Spicy Lion-fish with Dill Sauce

2 tsp lemon juice

1/4 c sour cream

2 Tbsp mayo

1 Tbsp fresh dill

1 Tbsp fresh chives

1 Tbsp capers

1/4 tsp salt

8 Lion-fish fillets

1 Tbsp creole seasoning

2 Tbsp butter

In a small bowl squeeze juice from 1 lemon. In medium bowl combine 2 tsp lemon juice, sour cream, mayo, dill, chives, and capers. Blend until well combined. Sprinkle creole seasoning on fillets. Heat butter in skillet. Pan fry fillets 2 minutes each side until browned. Place cooked fillets on a plate and serve with dill sauce.

Enlarged prostate, new surgical options!

Despite the medications you take to treat your enlarged prostate gland, a condition known as benign prostatic hyperplasia (BPH) – you will still have difficulty urinating. Your doctor most likely will say the next step is a surgical procedure to remove prostate tissue that's obstructing urine flow through the urethra.

Most commonly, the procedure is performed using a small surgical instrument inserted through your urethra. The chart below can help you compare the main options that are available to you. (Mayo Clinic).

### Captured

On the morning of 14th August 1719, five passengers boarded the small ship "Marechal D'Estrees" in the port of La Rochelle, France.

Our main character is named Francois Simars De Belle Isle. Simars came from Fontenay-Le-Comte in the Province of Poitou, France.

On the voyage to New Orleans the inexperienced Captain and crew showed they were not cut out to be transatlantic veterans. Once in the Gulf of Mexico, the ship stopped another vessel to ask directions to the mouth of the Mississippi River. They were told they had past the mouth by three leagues (90 miles) after being lost for twenty days.

When the ship turned around to head back to the east, they put in at the mouth of a bay they had seen before to go ashore for fresh water. The ship ran aground on a sandbar and got stuck. Instead of working out the problem, the Captain locked himself in his cabin and went to bed. When this happened the ensign locked himself in his cabin praying to God, if he was delivered, he would never set sail again. Someone had to take over, so the ship's pilot decided to have the crew and passengers to run from side to side of the ship to rock it loose from the bar. When the ship broke loose, the Captain came out of his cabin and took over.

The passengers decided they had had enough and put to shore to walk back. They were told it would take for or five days to reach New Orleans and to send a more confident captain and crew to take over the ship.

Among the five passengers were Simars, Duclos, Legendre, Courbet and Abain. These five took along with them their swords, guns, ammunition, and sea biscuits to last five days. After the first night on the beach, they walked to the east for four days. On the fifth day, they found themselves in an impassable swamp, turning around they found a small boat that had washed ashore, and they dragged it to the mouth of a small river. After a day's worth of cutting a path to launch it, being hungry, they killed and ate an entire deer.

The next day they rowed about twenty miles before they found the river ended into a small pond. Leading nowhere else, they drifted back down stream. They ended up at the same

spot they had first come ashore. With no food except a bird or two, the first passenger "Courbet" died of exhaustion.

The four left decided to take the boat out into the Gulf. After the first day of rowing, the second passenger "Legendre" died of exhaustion. The three left took the boat across the bay to explore the other side to the west. Simars and Abain left Duclos in the camp to explore inland. Duclos was too weak to follow his companions. After a few hours Abain gave up and set out to return to Duclos. Simars kept on for four more days, coming to a river too wide to cross. Simars went back to the camp to tell the other two men the news and found them both dead, leaving him alone.

For two days he ate nothing but oysters, grass and worms. After seeing Indians across the bay, he rowed over to meet them. They took his guns, swords, and clothes. They gave him some bird eggs to eat while he sat there naked. The next day they went to their village, where he was put on display.

He spent the summer scrounging for food. The men hunted bison and deer and the women dug roots to eat. When winter came, they forced him to gather firewood and water while beating his naked body with sticks.

Simars wrote a letter to send for help and gave it to a visiting Indian from another tribe. The letter went from tribe to tribe on display.

Once on a hunting trip, he had to run by their horses because he was not allowed a horse. The Indians would beat him with sticks if he stopped to remove thorns from his barefeet. On one trip they killed an enemy and brought the body back to their village where they ate him.

By chance, Simars' letter made it to Natchitoches, Louisiana, where an expedition was formed to find him. After fifteen months with the Attakapas Indians in Galveston, he made it to Nachitoches on 10 February 1721 wearing only an animal skin robe.

Simars was sent back to the shore where he first landed to build a fort. But it was not successful, the Indians were too hard to deal with. No one returned to the spot until 1735.



#### STRAWBERRY PRETZEL DESSERT

2 cups crushed pretzels (about 10 ounces) 3/4 cup unsalted butter, melted 3 tablespoons brown sugar, packed 8 ounce package cream cheese, softened 16 ounce container Cool Whip, or other non-dairy whipped topping, divided use 3/4 cup sugar 6 ounce package strawberry gelatin, or

two small packages

2 cups boiling water

3 cups frozen strawberries, thawed

Mix crushed pretzels, brown sugar, and butter.

Press into greased 9" x 13" baking dish and bake at 350 degrees for 10 minutes.

Cool completely. You may place in freezer for about 30 minutes to speed cooling time.

Mix sugar, cream cheese, and half the Cool Whip and place on cooled crust.

Bring water to a boil.

Add Jello and stir until dissolved. Then add strawberries.

Stir until thick.

If necessary, put in freezer for a half hour or so until mixture thickens.

Spread over cream cheese layer.

Freeze until firm--about 30-45 minutes.

Cover with foil (NOT PLASTIC WRAP!). Plastic wrap will adhere to the frozen surface and take off the beautiful

Refrigerate overnight before serving. If desired, serve with remaining Cool Whip-either spread over the strawberry layer or dollop on individual servings.


### NOTES:
